***DEFINITIONS:**

- **The ADHS J-1 Visa Waiver Program** supports waivers for primary care physicians (family or general practice, pediatrics, obstetrics/gynecology, and general internal medicine) and specialists in federally designated Health Professional Shortage Areas (HPSA), Medically Underserved Areas (MUA), or Medically Underserved Populations (MUP), and for psychiatrists in mental health HPSAs.
- **FQHC:** As defined in the United States Code Title 42 USC 1395x(aa)(4)(A)
- **FQHC Look-Alikes:** As defined in the United State Code Title 42 USC 1395x(aa)(4)(B),
- **Frontier:** As defined in 42 CFR 485.618(d)(1)(ii)(A)
- **Indian reservation:** as defined in A.R.S. § 11-801.
- **Language significantly represented in the area:** First and second most common spoken languages (other than English) in the specific county where the HPSA, MUA, or MUP are located. Extracted from Census 2000 SF3 QT-P16: "Language spoken at home."
- **Rural:** As defined in ARS § 36- 2171
- **Rural Health Clinic (RHC):** A Federally certified Rural Health Clinic as defined in the United States Code Title 42 USC 1395x(aa)(2)
- **Arizona Department of Corrections Facility:** means any portion of a state prison complex with a discipline appropriate Federal Health Professional Shortage Facility Designation.
- **Arizona Fit at Fifty HealthCheck Program Partner:** A Physician who will provide Colorectal Cancer Screening on behalf of a Practice or Facility who is contracted or has an agreement to provide colorectal cancer screening services with the ADHS Fit at Fifty Program. For example, this would be Gastroenterologist who will conduct an endoscopy or colonoscopy procedure or a Family Practice or Internal Medicine Physician who will provide a colorectal fecal occult immunochemical test.
- **Service Site:** means a facility that provides medical services and that is physically located in a federally designated HPSA, MUA, MUP.
- **Urban:** means a non-rural county or non-rural census county division.
